### **Group Package Terms and Conditions**

### THE TOUR PRICE INCLUDES

Air Transportation: Economy class. The round-trip airfares are based on the time of the reservation. Rates and times are subject to change without notice. Airfares, once issued, ARE NON-REFUNDABLE, NON-TRANSFERABLE AND CAN NOT BE USED TOWARDS FUTURE TRAVEL.

Land Transportation All land transportation as describe in the itinerary will be by Deluxe Motor Coach. Some may be equipped with Wi-Fi service.

**Hotels** Your hotels will be Touristic first-class with double occupancy (2 people per room with a private bath). *Neither Bella Travel (authorized agency), nor the trip coordinator are responsible for providing a roommate.* 

**Single Room** There is an additional cost per person specified on the registration form. Single rooms are limited and will be awarded on a first-come, first-served basis.

**Meal Plan** The meal plan varies accordingly with the package. Some packages offer two (2) meals per day and consists of both breakfast and dinner. You are responsible for your lunch and other meals if not listed in the itinerary.

**Baggage:** Most of the airlines limits all passengers to one (1) piece of checked luggage and one (1) carry-on. All passengers should check with the airline's carriers for up to date baggage weight and dimensions.

#### **BOOKING CONDITIONS**

A non-refundable deposit of \$500.00 per person is required at the time of booking. No reservation will be processed without a deposit and copy of passport. Final payment is due 100 days prior to your departure date. Registrations received late within 70 days of departure will require payment in full. No deposits will be accepted at this time.

#### ALL TYPES OF PAYMENTS MUST BE DIRECTLY TO BELLA TRAVEL.

Any cash payment must be done at the Bella Travel's office or using "ZELLE" to transfer money into Bella Travel's account (provided at registration).

- 1. **DEPOSITS**: Must be ZELLE transfer to Bella Travel's account and it is **non-refundable** for any reason
- 2. FORM OF PAYMENT: We accept ZELLE, money orders, and major credit cards.
- 3. There is an additional: 4% charge for each credit card payment.

#### **CANCELLATION AND REFUND POLICY**

**REGISTRATION NO REFUNDS** unless you purchased a trip cancellation plan at registration.

**CANCELLATION**: up to 100 days before the departure date will suffer a penalty of 50% of the amount already paid. **CANCELLATION** above 100 days from the departure date will suffer 100% penalty.

The right is reserved by Bella Travel to cancel the trip if the minimum number of paying people are not enough to be considered as group, within the 60 days period from the package launch date. In case of cancellation in this period Bella Travel will refund 100% of the amounts paid without penalty.
